Module 2: Business Opportunities and Trends in India

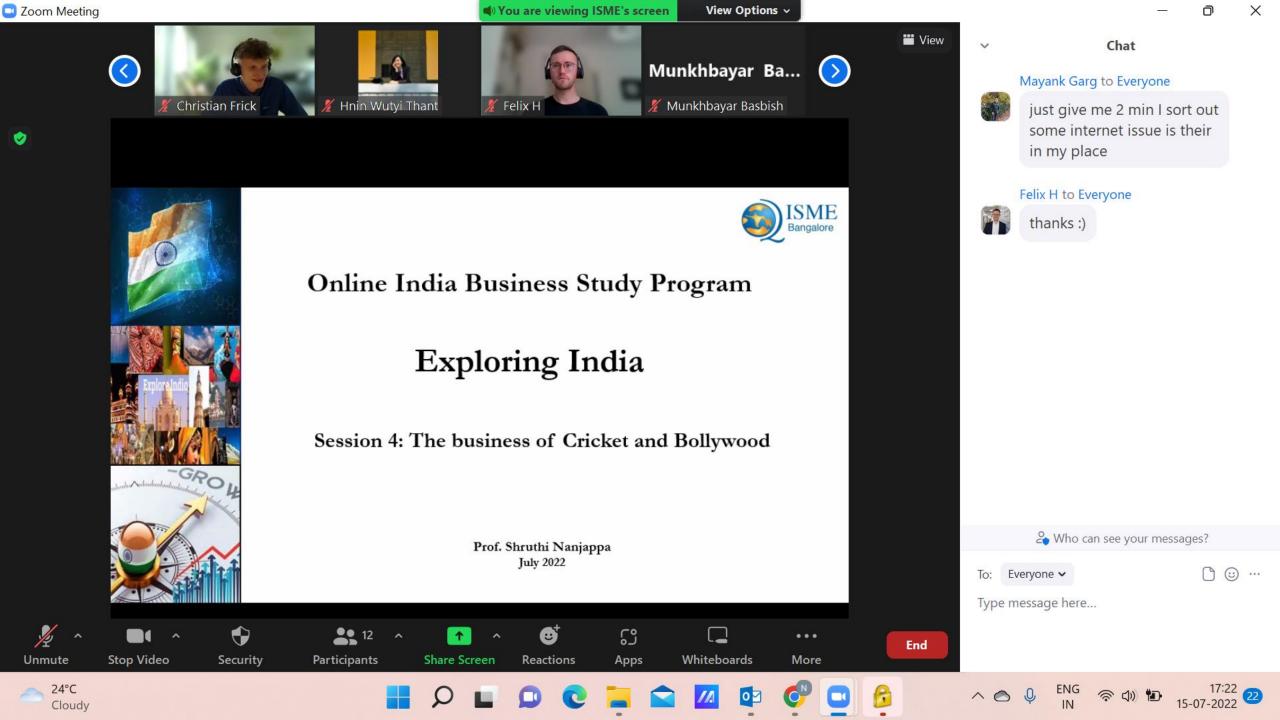
